

Advertising Agreement — Make Dixie Great Again Website

As an advertiser or prospective advertiser at the Make Dixie Great Again website (hereinafter “MDGA”) You consent and agree to the following terms and conditions.

1. The Sons of Confederate Veterans, P.O. Box 59, Columbia, Tennessee (800-380-1896) (hereinafter “SCV”) owns and controls the Make Dixie Great Again website. Any dispute involving this Agreement shall be adjudicated in Maury County, state of Tennessee.
2. You are a member in good standing of the Confederate Legion or the Sons of Confederate Veterans.
3. By submitting Your contact information, You are applying to advertise at MDGA subject to approval by the SCV.
4. If Your advertisement is approved and payment is received, SCV may cancel Your advertisement any time for any reason or for no reason at all and no reason shall be required.
5. You may cancel Your advertisement any time for any reason or for no reason at all and no reason shall be required.
6. Your cancellation must be sent by electronic means provided at MDGA or by mail to Make Dixie Great Again, Sons of Confederate Veterans, P.O. Box 59, Columbia, TN 38402.
7. Upon cancellation of Your advertisement, You grant SCV 90 days to send a pro-rata refund of pre-paid charges except when a discount for pre-paying has been applied. No refund shall be made for advertisements already placed.
8. SCV is not responsible for any results whether positive or negative that result from Your advertisement and You hold harmless SCV for all real or imagined consequences directly or indirectly resulting from Your advertisement.
9. You are personally responsible for statements, claims and promises made in your advertisement.
10. SCV is not responsible for statements, claims and promises made in your advertisement and You shall defend SCV against claims, damages and lawsuits that directly and indirectly result from your advertisement.
11. You shall not make false or misleading statements or claims.
12. You shall fulfill and complete all sales made in a timely, complete, and professional manner and submit prompt refunds when You unable to do so or when Your merchandise or services are insufficient or defective.
13. You shall make no claim that SCV endorses You, Your products or Your services.
14. Your advertisement, if approved, shall be placed at MDGA no more than 30 days from the first day of the month following approval and receipt of all required payments.
15. Advertising costs are provided at MDGA and are subject to change without notice.
16. Payment cycles run from the first day of the calendar month to the last day.
17. Payment is due no later than the 15th day of the month prior to the start of the next payment cycle.
18. Payment shall be made by automatic monthly charge to Your credit card through the electronic system at MDGA.
19. Cancellations must be received no later than the 15th day of the month prior to the next payment cycle.
20. SCV shall notify You by e-mail of changes to this Agreement and You agree that such notification shall be sufficient.
